#### **Community Assessment Summary**

NPHS is funded to serve 581 children throughout Hancock, Brooke, Ohio, Marshall, and Wetzel counties in West Virginia. NPHS provides Early Head Start, Head Start, Child Care Partnership and Home Visiting services through MIHOW & MIECHV. An annual Community Assessment is compiled and updated yearly with an in-depth assessment taking place every 5 years.

This report shows that all five counties continue to see a decrease in the population. The state of West Virginia continues to have the highest drug overdose rate in the nation. Four of the five counties NPHS serves are considered High Intensity Drug Trafficking Areas. The Northern Panhandle, which consists of all five of the counties NPHS serves continues to have some of the highest NAS rates in the state. The agency has seen a slight increase in the number of Child Abuse & Neglect Reports.

The number of children estimated to be eligible for our services has decreased in all five of our counties. This estimate considers the number of live births in each county which has dropped in three of the five counties as well as the current child poverty rate which has decreased in four of the five counties. Unemployment rates in each of the five counties are higher than reported the previous year. Four of the five counties reported an unemployment rate that is higher than the statewide average of 4.3%.

Health outcomes for the state of West Virginia continue to be poor with the state holding the highest rate of obesity in the nation. Along with the high rates of hypertension, diabetes, and depression. The agency has a contract with the Village Network to provide Mental Health Services to the children and families enrolled in our program. Local hospitals have implemented Mental Health Services to help fill the gap in our area. WV Birth to Three and the local LEAs provide services to the children with identified disabilities. The agency has partnerships throughout all five counties with the local county school boards and provides services to families through collaborative classrooms. As well as partnerships with five local daycares located in four of the five counties.

## **Overview**

Northern Panhandle Head Start promotes the school readiness of children from eligible families by providing a comprehensive program that addresses their cognitive, nutritional, health, social, and emotional needs.

NPHS's program is a combination of Early Head Start (EHS) funding which serves pregnant women, infants, toddlers, and their families, Head Start (HS) funding which serves preschool aged children (ages 3-5) and their families, and Early Head Start-Child Care Partnership (EHS-CCP) funding which serves infants and toddlers enrolled in collaborative child care centers. The program furnishes a learning environment that supports children's growth in literacy, language, mathematics, science, social, and emotional development.

NPHS emphasizes the parent's role as the child's first and most important teacher and builds strong relationships with the child's parents and family to increase the child's chances for success.





Health Advisory committee meets throughout the program year to discuss policies, health issues within the community, and address health service challenges along with establishing solutions.


### **Nutrition Services**

Nutritional meals are essential to healthy growth & development. Nutrition services include nutrition assessments, nutritious meals with modifications for childen with special dietary needs, and education to empower parents to help them make healthly choices for themselves and their children. Our program provides two nutritious meals and one snack per day following CACPF guidelines.

#### **Disabilities Services**

NPHS's goal in this area is to ensure that the developmental and social-emotional needs of each child are met, and their families are supported and effectively included in the full range of program activities. Each child participates in developmental and social-emotional screenings that are developmentally appropriate for young children aged birth through five. We use the results of these screenings to refer children to Part B or Part C agencies, who provide early intervention and special needs services.




#### **Mental Health**

#### **Child Development Outcomes & School Readiness**


NPHS School Readiness Goals encompass the foundational learning experiences that prepare children to be school ready. School readiness means children are ready for school, families are ready to support their children's learning,

and schools are ready for children.

#### **Head Start**

Head Start Child Development Outcomes (serving children ages 3-5) show results of child assessment data using the Early Learning Reporting System (ELRS), which follows the guidance of the West Virginia Early Learning Standards Framework and Head Start Early Learning Outcomes Framework and provides the continuum for learning for preschoolers. The ELRS data identifies where the program needs improvement to provide a quality education for all children.

This chart shows children's progress and percentage of gain in developmental domains from ELRS fall to winter.







# **Child Care Partnership**


#### **CCP School Readiness**

The Early Head Start-Child Care Partnership Program provides Early Head Start services to families attending child care centers. NPHS collaborates with five child care centers in the northern panhandle. Our current partners include The Children's Academy LLC in Hancock County, Little Bear of Weirton in Brooke County, Holy Family in Ohio County, Glen Dale Child Development Center, and Higher Hills Children's Center in Marshall County. There have been 63 child care teachers who have completed the CDA or ACDS program since July 1, 2015. Through the EHS-CCP program we have steadily maintained an average of 46.7% child care subsidy funding for the 72 enrolled children.



#### **Head Start CLASS Scores**

CLASS stands for Classroom Assessment Scoring System and is used by Head Start Programs across the country to measure quality teacher child interactions in preschool classrooms. Research shows classrooms with a score closer to a 7 within the three domains, the higher quality the interactions and more successful children will be academically and socially moving into their elementary school years and beyond. Head Start requires, at a minimum, an Emotional Support score of 5, a Classroom Organization score of 5, and an Instructional Support score of 2.5. They recommend for quality purposes an Emotional Support score of 6, a Classroom Organization score of 6, and an Instructional Support score of 3.



# **Family and Community Engagement**

Family involvement is the heart of a child's success in life. Parents and caregivers are a child's first most important and lifelong teacher and supporter of achievement. NPHS strives to work with the whole family to improve children's academic and social outcomes that lead to better futures for all. Adults in the family are encouraged to participate in classroom activities, attend parent meetings, help make policy decisions for our program, and enjoy all the fun events. Parents are empowered to develop a goal for their family and work toward that goal throughout the program year with the help of our staff.



# **Family Activity Night Attendance**






# **Community Involvement**


# **Annual Budget with Expenditures**






# Child Care Partnership Funds \$1,529,385\* Projected Budget 2024-2025





# MIECHV Funds \$238,500 Approved Budget 2023-2024




#### **Fiscal Audit**

The annual independent audit was performed by SR Snodgrass. – Certified Public Accountants and Consultants of Wheeling, WV. This audit was conducted in accordance with auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in Government Auditing Standards, issued by the Comptroller General of the United States. In accordance with the Government Auditing Standards, the report dated February 22, 2024, stated that there were no findings related to the financial statements and no findings or questioned or likely questioned costs for federal awards for the fiscal year ending June 30, 2023.

#### **Federal Review Outcomes**

The annual review is performed by the Administration for Children and Families (ACF) as part of a regulatory monitoring process of Head Start Programs. The most recent monitoring review was a video pilot project for CLASS. CLASS stands for classroom assessment scoring system which is a tool that measures the quality of interactions between teachers and children. The Office of Head Start piloted the use of Grant Recipient video recordings to conduct a CLASS review. The purpose of this pilot was to determine the viability of capturing video observations as part of monitoring for CLASS reviews. The scores obtained during this pilot will not be used by The Office of Head Start for Designated Renewal System (DRS) determinations; however, the scores will be used to help The Office of Head Start understand the current experiences of children in Head Start classrooms as a quality improvement opportunity and to offer training and technical assistance supports that build on existing program efforts to enhance professional development and teacher-child interactions. Our CLASS video pilot review was conducted between November 16, 2022, and January 14, 2023. NPHS, Inc. scores were as follows Emotional Support 6.0089, Classroom Organization 5.8512, and Instructional Support 2.8452. These scores are above the competitive threshold that keeps us out of the DRS determination. We scored just slightly below the required score of 6 for the quality threshold for Emotional Support, and Classroom Organization.
